



### Message from Kathleen Schuessler, Superintendent of Schools

I would like to take this opportunity to thank our community for the support you have given the students and staff of Wyoming Central School. Our District continues to have a reputation of excellence as a small rural K-8 school. The dedication of our teachers, staff and students, through a very tough year, -everyone working together- to make Wyoming a fantastic place to learn. This school has provided us with a number of opportunities including:

- Assessing student's achievement and learning loss thru the COVID Pandemic has been done through Reading Recovery, I Ready, and individual assessments.
- Curriculum was taught using chrome books for easy transition to remote learning when needed. We will continue with chrome books for future needs. We have a new reading series this year for English Language Arts and Literacy along with continuation of Reading Recovery in our primary grades.
- Finances, School Safety and Possibility of a New Program
  - \* With respect to the financial piece of the District, we, at this time, find ourselves in a positive environment. We still, however, will continue to take a conservative and thorough approach.
  - \* Our Capital project is complete, the parking lots, drop off and pickup area is working well. Windows have been replaced thus helping to eliminate loss of heat, the roof work is completed, new boilers are in and working well. Bottle fillers connected to drinking fountains are used by everyone. At the north side of the building a new ramp was also installed for better use and safety.

- \* A new program may be in the future at Wyoming. We are looking at adding a Pre-K, four year old, half day program. We anticipate a minimum of ten registered students for this program. Without the minimum students, the program will not be able to run. Transportation of students would be 100% on the parents. Students would be dropped off in the morning and picked up at the end of the half day. The Pre-K would give our students the head start they need to be successful in today's society and education.
- \* Also, we have a larger number of kindergarteners coming in this next year. With the current guidance from the state we may need a second kindergarten class.
- Every year each school is able to have a 100k project that is aided by the state. This year we updated our gym. What does that mean? All trim work has been scraped and painted, new mats have been installed and our gym floor has had the dead spots fixed, water damaged floor boards replaced and then the floor was sanded, repainted and sealed.
- This next year we will apply to have HVAC (heating, ventilation and air conditioning) upgraded and/or fixed.

This next year, we are hopeful that we will have all attending our school concerts, sporting events, Open house and our Community Holiday dinner. We are looking forward to the communication in person once again.

Without the support of our community none of this would be possible. Your support provides the Wyoming Central School District the framework that enables us to continue to offer a quality education to all our students.

#### **Proposed Budget Figures:**

Throughout the last several months we have worked hard on developing a budget that protects our instructional program and recognize the ability of our taxpayers to support the budget.

Wyoming Central School's property tax cap for the 2021-2022 fiscal year is 3.36%.

The proposed budget for 2021-2022 is \$5,832,070, which is an increase of 1.59% over the 2020-2021 budget. The tax levy for the 2021-2022 school year is \$2,086,499 a 3.36% increase.

# Annual Budget Referendum 2021-2022

# What's on the ballot?

Eligible voters in the Wyoming Central School District will be asked to consider the following propositions:

### **PROPOSITION #1: Annual Budget**

#### Shall the following resolution be adopted?

**BE IT RESOLVED,** that the Board of Education of the Wyoming Central School District shall be authorized to expend the amount of \$5,832,070.00, to meet the expenditures for the fiscal year 2021-2022, AND FURTHER that said Board of Education shall be authorized to levy and collect a tax upon taxable property of the School District in an amount necessary therefore.

### **PROPOSITION #2: Board Election**

**BE IT RESOLVED,** to elect one (1) member of the Board of Education for one (1) five (5) year term commencing July 1, 2021 and expiring on June 30, 2026 to succeed Danyle Raines, whose term expires on June 30, 2021. All board positions are at-large.

### PROPOSITION #3: Authorization to Establish 2021 Building Capital Reserve Fund

#### Shall the following resolution be adopted?

**BE IT RESOLVED**, that the Board of Education of the Wyoming Central School District, Wyoming County, New York, is authorized to establish a capital reserve fund in accordance with New York State Education Law Section 3651 to be known as the "2021 Building Capital Reserve Fund."

The purpose of such fund shall be used to finance, in whole or in part, the construction, reconstruction, additions, alterations, renovations, and improvement of school buildings and facilities and the acquisition and installation of machinery, equipment, apparatus, or furnishings and costs incidental thereto, such capital costs being of a type that would be eligible for financing under the Local Finance Law.

The ultimate amount of such fund shall not exceed Eight Hundred Thousand Dollars (\$800,000) plus earnings thereon. The probable term of such reserve fund shall be 10 years, but said fund shall continue in existence for its stated purpose until the fund is exhausted or otherwise liquidated in accordance with the Education Law.

The source of monies to be paid into such reserve fund shall include: (a) current and future unappropriated fund balance from the General Fund of the District as directed by the Board of Education; (b) any appropriations authorized by the voters from time to time; (c) New York State Aid received and authorized by the Board of Education; and (d) fund balances transferred from other reserve funds of the District, as authorized by law.

### **PROPOSITION #4: Wyoming Free Circulating Library Association**

#### Shall the following resolution be adopted?

**BE IT RESOLVED**, that the sum raised by the annual levy of a tax upon the taxable real property within the Wyoming Central School District for the purpose of funding a portion of the operating expenses of the Wyoming Free Library Association shall be increased by Two Thousand Dollars (\$2,000.00) from the annual amount of Thirty-Seven Thousand Four Hundred Ninety-Five Dollars (\$37,495.00) to the annual amount of Thirty-Nine Thousand Four Hundred Ninety-Five Dollars (\$39,495.00) commencing with the 2020-2021 school year.

# What is the Three-Part Budget?

New York State law requires that all school districts present the proposed budget in three parts: Program, Capital and Administrative. The law also states that the Three-Part Budget must exclude any propositions or voter-authorized adjustment.

The Program component of the proposed budget includes expenses associated with our instructional program, teacher salaries and benefits, transportation costs, special education, legal services, and community services.


The Capital component contains building and grounds maintenance, custodial services, utilities, administrative services, tax refunds and judgments, capital expenses, and debt services.

The Administrative component includes costs associated with running the Superintendent's/ Principal's Office, Board of Education expenditures, finance/legal services, and personnel.

# Voter Qualifications


In order to participate in the voting process, you must be...

# Percent of Total Budget Information




# Absentee Ballot Information

Applications for absentee ballots may be obtained from District Clerk Nancy Norton during school hours. The completed application for an absentee ballot must be received by the District Clerk at least seven days prior to the election if the ballot is to be mailed, or the day before the election if the ballot is to be issued in person.

The District Clerk must receive completed absentee ballots no later than 5:00 pm on Tuesday, May 18, 2021.

### **Voting Procedures**

*How do I sign in?* On the day of the vote between the hours of 9:00 am and 9:00 pm, go to the sign in table where you will be required to sign your name and township in which you reside. You will also be asked for the correct spelling of your name, and your address by our election workers. Our Election Workers also reserve the right to ask for a photo ID.

*Where and how do I complete the ballot?* Where and how do I complete the ballot? At the sign-in table, you will be given a paper ballot and privacy sleeve and then instructed to go to a privacy booth. Once at the privacy booth, review the paper ballot, and make your selections using the pen provided. Be sure to place a for M or M in the square. Select either yes or no for each proposition and vote for one (1) candidate you would like to see on the Board of Education. After you have finished filling out the ballot, fold your ballot in half so your vote is on the inside. Place your folded ballot in the ballot box.
