Frequently Asked Questions.

Q. Why is the district having a Capital Construction Vote?

A. The Wyoming Central School District is committed to providing a well-maintained facility and a safe learning environment for students and public use. Most of the work included in this proposed Capital Construction Project is "asset preservation." Routine facility maintenance and repair work is typically funded in the annual District budget, with local taxpayers bearing the full cost. However, sizable renovations, repairs and replacement of "end of useful life" items such as those included in this project, would have a MAJOR IMPACT on the tax levy if included in the annual District budget. In fact, it would be virtually impossible to raise enough funds locally to accomplish.

Q. What is the total cost of the proposed project? A. The total cost is \$5,375,000.

Q. Are there any capital reserve funds being applied to this project?

<u>A.</u> The district has \$1,500,000 available in "capital reserve" funds. These funds, which the voters approved, allow the District to set aside money to help fund the project.

Q. How will it affect my taxes? A. There will be NO ADDITIONAL IMPACT to your tax levy from the capital construction project. The capital construction project would be paid for using a combination of State Building Aid and the District's Capital Reserves. The Capital Reserves are savings accounts which can be used only for capital construction projects. With the current 2023-2024 State Aid Building Ratio of 80.1% and the District's Capital Reserve funds the capital construction project will not cause an increase in the District's tax levy related to capital purposes.


