EXTRACT OF WILL - ARTICLE XIV

July 16, 1927 - Sarah Jeanette Keith

Keith Educational Scholarship Fund

The purpose of the trust is to “assist needy boys and girls, who have not sufficient means of their own to obtain a higher education.” Will directions further establish priority of consideration to the residents of the *Wyoming Village* and specify that scholarship grants should be used for “educational expenses.” The trustees “shall determine the worthiness of all applications who shall apply to them.” Worthiness by direction of the will is to be based on need and the subjective decision of the trustees, as to those applicants who are the most deserving.

Completed applications of all candidates must be submitted to the Superintendent’s Office, Wyoming Central School, no later than 3:00 P.M. on Friday, May 12, 2017.
